The North East Youth Sheep Show has become, over the last 35 years, a very successful and large event. In order to ensure the quality of this event, the education of the youth and their families and promote sheep and agriculture to the general public, the show's sponsors are endorsing the National Show Ring Code of Ethics. It is each family's responsibility to read this Code and follow these guidelines. The Rule Enforcement Committee will review any complaints or actions deemed to violate these ethics. ANY EXHIBITOR, PARENT, OR LEGAL GUARDIAN, MAY BRING A CONCERN OR PROBLEM TO ANY YOUTH SHOW COMMITTEE MEMBER. THAT COMMITTEE MEMBER MAY ADDRESS THIS, OR IF NEED BE, BRING IT TO THE RULE ENFORCEMENT COMMITTEE. THE RULE ENFORCEMENT COMMITTEE HAS FINAL SAY ON ANY SITUATION. It is very important to the show management that youths conduct themselves with respect for themselves, their animals and people around them. Any action that violates these ethics will be grounds for disqualification from the show and possible immediate dismissal from the show grounds:

- (a) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives or show officials, before, during or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect, and no person shall direct abusive or threatening conduct toward them.
- (b) No owner, exhibitor, fitter, trainer, or absolute responsible person shall conspire with another person or persons to intentionally violate this Code of Conduct or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this Code of Conduct. Violation of this Rule shall subject such individual to disciplinary action.
- (c) THERE WILL BE NO alcohol or drug use by youth show exhibitors for the duration of the event at the show facilities. If a youth show exhibitor is caught consuming either of these substances or found inebriated or in an intoxicated state, he or she will not be allowed to participate and will forfeit any premiums earned.

In addition to complying with all laws and regulations governing animal health issues all fairs must adopt and enforce the following rules for governance of the fair:

#### 2019 Fairs - Animal Health Rules

NO animal will be admitted to the fairgrounds unless it meets the requirements below. NO animal is to be unloaded or enter a barn or tie-out stall until the animal and its paperwork have been inspected and approved for entry.

General Rules for All Animals

- 1. All animals must be in proper physical condition, be properly identified and free of visual evidence of infectious, contagious or parasitic disease at time of arrival. Specific diseases and conditions which will disqualify an animal for entry are identified for each species in the following sections of the rules. Animals of any species with open or draining wounds will not be approved for entry.
- 2. Evidence of infectious, contagious or parasitic disease or failure to produce the necessary documents for health certification, vaccination or testing will result in the animal's rejection for entry. THE INSPECTOR'S DECISION IS FINAL.
- 3. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only, and except for surgical procedures performed by a duly-licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 4. Official ID: See Final Rule: Summary of Traceability for Livestock Moved Interstate (Summary of general Requirements by Species)
  All livestock must have proper official, individual ID as required for the species, e.g. official metal ear tag, tattoo, scrapie tag, or microchip. Breed registration forms must accompany health certificates when used as part of official identification.
- 5. Health Certificates: -One Official Certificate of Veterinary Inspection (OCVI) may be allowed for animals of the same species to be exhibited at fairs or shows in any of the New England states (CT, \*ME, MA, \*\*NH, RI, and \*\*\*VT) when submitted with an itinerary of the dates and locations of the events at which the listed animals are expected to be shown. Only animals that are healthy at the time of shipment

may be moved. Note that \*ME, \*\*NH, and \*\*\*VT have additional requirements. Certificates of veterinary inspection in these states are valid for a shorter period of time and may have additional language, movement and permit requirements.

For the 2019 Show and Fair Season, livestock animals being exhibited in New England states must have official certificates of veterinary inspection (OCVIs) that meet the following requirements:

- a. CT, MA, and RI: OCVIs issued on or after January 1, 2019 may be used for those animals being shown at multiple fairs and shows in CT, MA, and RI through the 2019 show/fair season ending October 31, 2019.
- i. ME: An importation permit for exhibition animals is also required. Contact ME State Veterinarian's Office (207-287-3701) for permits/questions
- ii. MA Special Note: The Big E Fairgrounds in West Springfield requires a CVI issued within the prior 30 days for all horses entering the premises for any show, fair, or exhibition.
- iii. NH: To qualify for the extended CVI, animals exhibited in NH must originate in a New England state and move on OCVIs issued on or after April 1, 2019 to participating NH fairs and shows from July 1 to October 31. The extended CVI is not available for animals that do not reside in New England. Contact NH State Veterinarian's Office (603) 271-2404 for details and permits.
- iv. VT: Contact the VT Animal Health Office (802-828-2421) for specific import requirements that deviate from the general information in this letter and must be met for legal import of livestock.
- b. A single OCVI from the animals' home state may be completed for travel to and from the New England states in which the animals will be exhibited. MA animals being shown ONLY in MA may substitute a signed, dated letter on the letterhead of an accredited veterinarian for an OCVI if all required information is included and all additional requirements are met.
- c. Multiple animals of the same species may be listed on one health certificate with appropriate individual IDs and descriptions. Animals of different species may not be listed on the same official health certificate.
- d. An itinerary of the names and locations for each New England fair or show at which owner expects to show the listed animals and the dates when each animal are expected to be on each site, must be prepared by the owner and presented to the veterinarian at the time the OCVI is written
- i. A copy of this planned itinerary must be attached to the official health certificate (import and export) for it to be used for more than one fair or show.
  - ii. That proposed list should be signed by the veterinarian and the owner/ exhibitor and reference the relevant OCVI number(s).
- e. The name and address of the first show or fair where the listed animals will be exhibited is to be used as the "destination" on the OCVI form. In addition, "See attached list" or a similar statement directing Animal Health Officials or Fair Inspectors to the attached proposed itinerary must be included.
- f. Exhibitors must keep an accurate list of the show locations and dates when their animals were actually on the show/fairgrounds. This record must be available to fair inspectors at each inspection and check-in.
- g. Any animal listed on an OCVI that becomes sick must remain home. If the animal is refused entry to any exhibition during 2019 for health reasons it must have a new health certificate issued by an accredited veterinarian within 30 days of the next interstate movement.
- h. Any New England state may end their participation in this agreement and revert to the standard published requirements for livestock imports in the state at any time, in the event of foreign animal disease outbreak or changes to state legislation.

  Sheep: See 9 CFR 79 and Massachusetts Emergency Order 1-AHO-06.
- 1. No sheep will be allowed entry from flocks in which Scrapie has been diagnosed or in which animals are under surveillance for Scrapie during the previous eighteen months. Based on the Federal Scrapie Eradication Program (FSEP) and the Massachusetts Emergency Order 1-AHO-06, sheep of any age or sex brought to show or exhibition from either out of state or within the state must possess a USDA approved individual identification tag, tattoo, or electronic implant consistent with requirements of the FSEP. Information on approved tags, tattoos, and electronic implants is available from the USDA APHIS office in Sutton, MA at 508-363-2290.
- 2. No sheep will be permitted entry from flocks in which Soremouth has existed or in which Soremouth Vaccine has been administered in the previous sixty (60) days.
- 3. Sheep must be free from visual evidence of foot rot, sore mouth, pink eye, ringworm, and open and draining wounds.
- 4. While not required, it is strongly recommended that sheep be currently vaccinated against rabies.

#### 

#### EACH EXHIBITOR IS RESPONSIBLE FOR READING THESE RULES & BEING FAMILIAR WITH THEM.

- 1. Each exhibitor will be solely responsible for any loss, injury and/or damages done by or arising from any animal exhibited by him/her and shall indemnify the New England Sheep & Wool Growers Association and the North East Youth Sheep Show against legal or other proceedings in regard thereto. Upon this condition only are entries accepted.
- 2. This show is open to all youths 21 years old and under **as of January 1** of the current year. Exhibitors may have non-exhibitors showing or helping to show their second animal in a class, provided the show help is 21 years old and under as of January 1<sup>st</sup>. Additional show help is required to buy a t-shirt to be worn in the show ring. Co-chairmen may ask the show help for I.D. for age verification.
- 3. All sheep <u>must be registered</u> in the name of the exhibitor, or owned in a Youth Partnership where all names are on the registration papers are youth. <u>No Partnerships</u> with a farm or adult(s) are accepted. Partnerships are considered one exhibitor but any party in the partnership may enter in a Fitting & Showmanship class with a different sheep than the other partner(s). <u>At least one partner must</u> enter a Fitting & Showmanship class. <u>NO LEASED SHEEP ACCEPTED.</u>
- 4. All sheep shown in group classes must be registered under the same name. Individuals in group classes must have been shown in single classes. Premiums limited to two per individual class and one per group class.
- 5. **Registration papers must be checked in between 8:30 AM and 9:30 AM on Friday** with the individual breed secretary (specific tables will be set-up for checking in papers by breed). All Market Lambs must be checked in and weighed-in at this time. HEALTH AND REGISTRATION PAPERS MUST BE AVAILABLE THROUGHOUT THE WEEKEND TO BE SHOWN UPON REQUEST. Sales receipts may be used on recently purchased sheep. All sheep must be owned by July 1<sup>st</sup> of the current year. Exhibitors are limited to two premiums per individual class.

- 6. All sheep must have the required identification as per order of their particular national breed organizations and the federal identification regulations. Registration papers and ear tag/tattoo numbers must match.
- 7. Humane treatment of animals is required at all times. The use of showing and/or handling practices or devices such as striking animals to cause swelling, use of muzzles, using electrical contrivance, or other similar practices are not acceptable and are prohibited. Any complaints will be addressed individually. Sheep should be properly handled at all times, including loading and unloading of animals, and leading on halter.
- 8. A walk around Vet Check will be done Friday morning by a representative from Tufts Veterinary Field Service. All animals entered in this show will be subject to the inspection for evidence of infectious or contagious diseases, i.e. foot rot, fungus, sore mouth, pinkeye, etc. Evidence of these or other contagious/infectious diseases will result in animal's removal from the barn and they will not be allowed to participate in the show. Committee's decision will be final. If disputed, the veterinarian expense will be covered by exhibitor. ALL SHEEP MUST BE ACCOMPANIED BY AN APPROPRIATE INTERSTATE HEALTH CERTIFICATE FROM THE STATE OF ORIGIN. Prior entry permits are not required for show purposes. HEALTH AND REGISTRATION PAPERS MUST BE AVAILABLE THROUGHOUT THE WEEKEND TO BE SHOWN UPON REQUEST
- 9. Showing sheep on a halter is optional. (Breed Secretaries do encourage inexperienced and younger showman to use halters.) All animals must be washed, except for wool breeds which must be properly prepared for show.
- 10. All exhibitors must be clean and neat. The accepted exhibitor attire for the show rings on Friday for the Market Lamb Show and Saturday for the Fitting & Showmanship Classes and Saturday night's Breed Shows will be appropriate show ring attire with shirt and long solid-colored pants in good repair. This means no sweats and no revealing attire allowed. Also, no graphics or logos on shirts and no farm shirts. 4-H and FFA logos are accepted. NOTE: On Sunday the proper attire for the show ring will be 2019 NEYSS issued T-shirts with long solid colored pants in good repair. This attire shall be worn by ALL EXHIBITORS ALL DAY. Proper foot attire must be worn at all times.
- 11. Non-refundable entry fee is \$5.00 per head for all breeds and \$2.00 per fleece in Fleece Show. No entry fee is required for Fitting & Showmanship or Group classes. Fees are forfeited if animals do not show. Entry fee MUST ACCOMPANY entry form. Any entries received with no payment will be subject to double entry fees paid at time of check-in. MAKE CHECKS OUT TO: "NESWGA".
- 12. ENTRY DEADLINE IS JUNE 15, 2019. Late sheep entries will be subject to late entry fee of \$10 per head. A late entry is an entry that is postmarked AFTER June 15<sup>th</sup> or that is received by email, phone, text or Facebook AFTER June 15<sup>th</sup>. ALL ENTRIES AND FEES ARE TO BE MAILED TO: SCOTT POITRAS, 95 HOLLOW ROAD, BRIMFIELD, MASSACHUSETTS 01010.
- 13. Grain, hay, bedding and water pails *MUST BE* furnished by the exhibitor. All animals must be properly bedded and watered at ALL TIMES. No carpeting allowed.
- 14. All lambs must have lamb's teeth. Yearlings cannot have more than 4 permanent teeth in use.
- 15. A breed must meet the minimum requirements to show as an individual breed of three (3) exhibitors and ten (10) breeding sheep as of Thursday, July 18<sup>th</sup> at 11:00 PM.
- 16. Fitting & Showmanship Class participation is <u>MANDATORY</u> for all exhibitors <u>with an ANIMAL THEY OWN</u>. Exhibitors who show in the wrong class will forfeit premiums. <u>All breeds are shown together. Classes will be determined by age of exhibitor as of January 1<sup>st</sup> as follows:</u>
  - **NOVICE** will include those 9 years old and under as of January  $1^{st}$ ; the classes will be divided by age as follows: Class 1 = 6 years old and under; Class 2 = 7 years old; Class 3 = 8 years old; and Class 4 = 9 years old.
  - **JUNIOR** will include those 10 years old through 13 years of age as of January 1; the classes will be divided by age as follows: Class 5 = 10 years old; Class 6 = 11 years old; Class 7 = 12 years old; and Class 8 = 13 years old.
  - **INTERMEDIATE** will include those 14 years old through 17 years of age as of January 1; the classes will be divided by age as follows: Class 9 = 14 years old; Class 10 = 15 years old; Class 11 = 16 years old; and Class 12 = 17 years old.
  - **SENIOR** will include those 18 years old through 21 years of age as of January 1; the classes will be divided by age as follows: Class 13 = 18 years old; Class 14 = 19 years old; Class 15 = 20 years old; and Class 16 = 21 years old.
  - All showman in each Class will be placed and only the winner in each Class will come back to compete for the Overall Supreme award in that Division. The overall award of a Captain's Chair in each Division is donated by Kent Feeds.
- 17. LIMITED ADULT HELP FOR EXHIBITORS IN PREPARATION FOR SHOW WHILE ON THE FAIRGROUNDS WILL BE ALLOWED WITH PERMISSION OF GUARDIAN, BREED SECRETARY AND SHOW CHAIRMEN (This show "officially starts" on Thursday at 11:00 PM, and therefore these rules apply beginning at 11:00 PM on Thursday and continuing Friday, Saturday, and through end of show on Sunday). If an exhibitor feels he/she needs some instructional help, they should see the breed secretary first. Any exhibitor, parent, or legal guardian may bring a concern or problem to any youth show committee member. That committee member may address this, or if need be, bring it to the rule enforcement committee. The rule enforcement committee has final say on any situation.
- 18. To help defray costs of facility rental, ALL overnight camping will be charged \$25 prepaid to NESWGA c/o Scott Poitras. Electric and water hook ups will be available. Post paid fee will be \$40 and will be collected upon arrival at show, if not a prepaid camper or tent. Tony Patti will be collecting fees and verifying payment at the show, please go to DOOR 5 to check in your camper or tent. To pre-register, see form enclosed.
