# NEW ENGLAND SHEEP AND WOOL GROWER'S ASSOCIATION WAIVER FOR ENTRY AGREEMENT OF RESPONSIBILITY AND LIABILITY:

The New England Sheep and Wool Growers Association, and its directors, officers, employees, agents, representatives and/or other officials (hereinafter collectively referred at as the "NESWGA"), and each owner and/or exhibitor, and each of their respective employees, agents, representatives and/or other associates; and, in the case of minor exhibitors, their respective parents or guardians, and each of their respective employees, agents, representatives and/or other associates (hereinafter collectively referred to as the "Participants"), hereby agree with the responsibilities and acknowledge liability as follows:

- At no time shall the NESWGA assume care, custody or control of any animals, livestock and/ or other personal property of any Participant.
- At all times the participants shall have full control, custody and will care for, feed and keep safe their animals, livestock and other personal property all in accordance with the rules and regulations of the NESWGA and the show management ("Management"). In no case will the NESWGA or Management be responsible for any loss, injury or damage to any animal, or loss, injury or damage done by or arising from any animal exhibited by any Participant.
- Participants shall indemnify and hold harmless the NESWGA from and against any and all damages, losses, costs, expenses and/or other liabilities incurred including, but not limited to, any and all consultant fees, legal fees and/or court costs, NESWGA and/or Management labor costs and expenses as well as all cost and expenses related to blood, tissue, urine, milk or carcass sampling and testing incurred as a result of any NESWGA rule or regulation violation, including, but not limited to unethical fitting, udder tampering, filling, illegal or non-approved use of drugs, medication and/ or prohibited substances in connection with Participant's involvement in any NESWGA sponsored event.
- Participant's knowingly, willingly and voluntarily acknowledge the inherent risks associated with the exhibition of
  animals and know that such activities can lead to bodily injury, illness including communicable diseases, arising
  out of the unpredictable behavior of animals and exposure to contact with other participants and other undefined,
  not readily foreseeable and presently unknown risks. A participant voluntarily and knowingly assumes all such
  risks and responsibility that they incur as a result of their participation in any NESWGA event.
- A signed entry form shall serve as the Participant's agreement to comply with all rules and regulations contained within this document and all other NESWGA mailings and/ or postings, including, without limitation, the International Association of Fairs and Expositions ("IAFE") Code of Ethics, the National Show Ring Code of Ethics as approved by the North American Livestock and Rodeo Managers Association, The Purebred Dairy Cattle Association Show Ring Code of Ethics, International Lama Registry("ILR") Show Division Handbook and the Alpaca Owners and Breeders Association ("AOBA") Show Division Handbook (hereinafter collectively referred to as the "Rules and Regulations").

Any unsigned entry will be returned with any accompanying payment. The signed entry form certifies that each signing Participant has read, understands and agrees to abide by all of the foregoing Rules and Regulations. If the Participant is a minor, the Participant's parent or guardian must sign the entry form acknowledging they have read the Rules and Regulations and agrees to observe and abide by all such Rules and Regulations. Each such parent or guardian further acknowledges that they have read and explained this Agreement to the Participant and explained and cautioned the Participant with respect to the penalties for use of prohibited substances, unethical fitting and tampering with livestock.

# NORTH EAST YOUTH SHEEP SHOW SHOW MANUAL



The New England Sheep and Wool Grower's Association (NESWGA) and the North East Youth Sheep Show (NEYSS) is committed to producing a professional show that provides a positive, competitive, and safe experience for all levels of shepherds and their families. Our combined goal is to teach and guide all levels of showmen to not only gain confidence in the show ring, but to also garner the skills needed to be successful shepherds. Emphasis is placed on leadership, integrity, and sportsmanship.

Our show allows our most novice participants to our most senior participants to take ownership of their sheep, their show, and their future roles in the industry. Our mission is reflected in our show rules. We appreciate your help and cooperation in making this a great experience for our youth!

We rely on your help. Please look for opportunities to volunteer and make this show experience even better for our youth.

## **Covid 19 Regulations**

Updates and information regarding Covid-19 will be available as the show date gets closer.

Reminders of Covid- 19 protocol will be announced in the building and on Facebook. Reminders will be sent daily on the Facebook page.

- If you or a family member are feeling ill the week of the show, please do not attend.
- Please abide by all floor markings and requests for direction of movement.
- Social distancing is requested. In situations where social distancing is not an option, please wear a mask.
- Please let the show committee know if you are feeling ill.
- No sleeping or preparing food in the barn
- Exhibitors are not required to wear a mask in the show ring for safety purposes, however, all show ring personnel will wear a mask to keep participants safe, when medically possible.
- Spectators must maintain appropriate distance at ringside. No leaning on fences or crowding entry/exit points.
- All pens will be assigned to allow distancing between exhibitor groups. That space may not be used as a tack pen.
- Limit the number of animals in show ring and warm up ring at any one time.
- Staff and announcer table will remain at ringside with appropriate social distancing.
- Official photographer only for backdrop photos. Photographer to wear mask. Limit number of animals and people in the photo. Limit the number of animals waiting for a photo.
- Showers will be thoroughly cleaned as many times as needed.
- Camping will be supervised and adhere to all state guidelines.
- Tenting will be supervised and adhere to all state guidelines.
- Food service will be provided and maintained by ESE provided purveyor
- All manure removal will be handled by ESE provided vendor.

## **Code of Conduct**

# EXHIBITORS AND FAMILIES ARE RESPONSIBLE FOR READING THESE RULES & BEING FAMILIAR WITH THEM.

The North East Youth Sheep Show has become, over the last 36 years, a very successful and large event. Participants and their families are encouraged to participate fully in all that the youth show has to offer, and are requested do so in a manner that is safe, that adds to the community, and creates a positive experience for everyone at the show. To ensure the quality of this event, the education of the youth and their families, and the promotion of sheep and agriculture to the general public, the show's sponsors are endorsing the National Show Ring Code of Ethics. It is each family's responsibility to read this Code and adhere to these guidelines for the duration that they are participating in the show.

It is very important to the show management that youths conduct themselves with respect for themselves, their animals and people around them. Exhibitors shall at all times conduct themselves with honesty and good sportsmanship. Their

conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. Any action that violates these ethics will be grounds for disqualification from the show and possible immediate dismissal from the show grounds:

- (a) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives or show officials, before, during or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect, and no person shall direct abusive or threatening conduct toward them.
- (b) No owner, exhibitor, fitter, trainer, or absolute responsible person shall conspire with another person or persons to intentionally violate this Code of Conduct or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this Code of Conduct. Violation of this Rule shall subject such individuals to disciplinary action.
- (c) There will be NO alcohol or drug use by youth show exhibitors for the duration of the event at the show facilities. If a youth show exhibitor is caught consuming either of these substances or found inebriated or in an intoxicated state, he or she will not be allowed to participate and will forfeit any premiums earned.

#### **General Rules**

- 1. Each exhibitor will be solely responsible for any loss, injury and/or damages done by or arising from any animal exhibited by him/her and shall indemnify the New England Sheep & Wool Growers Association and the North East Youth Sheep Show against legal or other proceedings in regard thereto.
- 2. This show is open to all youths 21 years old and under as of January 1 of the current year.
- 3. All sheep must be registered in the name of the exhibitor, or owned in a Youth Partnership where all names on the registration papers are youth. No Partnerships with a farm or adult(s) will be accepted. Partnerships are considered one exhibitor, but any party in the partnership may enter in a Fitting & Showmanship class, provided the individuals are showing different sheep. At least one partner must enter a Fitting & Showmanship class. NO LEASED SHEEP ACCEPTED.
- 4. All sheep shown in group classes must be registered under the same individual. Animals in group classes must have been shown in single classes. Class premiums limited to two per single class and one per group class.
- 5. Registration papers must be checked on Friday between 11:00 am-1:00 pm. All market lambs must be checked and weighed in at this time. Check-in procedure will be explained during the exhibitors meeting on Friday at 10:00
- 6. All sheep must have the required identification as per order of their particular national breed organizations and the federal identification regulations. Registration papers and ear tag/tattoo numbers must match.
- 7. All lambs must have lamb's teeth. Yearlings cannot have more than 4 permanent teeth.
- 8. A walk around **veterinarian check** will be done **Friday** morning by a representative from Tufts Veterinary Field Service. All animals will be subject to inspection for evidence of infectious or contagious diseases (i.e. foot rot, fungus, sore mouth, pinkeye, etc.). Evidence of these or other contagious/infectious diseases, or sheep not in proper condition, will result in the animal's removal from the barn and they will not be allowed to participate in the show. The Show Committee's decision will be final. If disputed, the veterinarian expense will be covered by the exhibitor.
- 9. All sheep must be accompanied by an appropriate interstate health certificate from the state of origin. Prior entry permits are not required for show purposes.
- 10. Health and registration papers must be available throughout the show to be shown upon request. Sales receipts may be used on recently purchased sheep. All sheep must be owned by July 1st of the current year
- 11. Humane treatment and proper handling of animals is required at all times, including when loading/unloading. The use of showing and/or handling practices or devices such as striking animals to cause swelling, use of muzzles, using electrical contrivance, or other similar practices are prohibited. Any complaints will be addressed individually.
- 12. Grain, hay, bedding and water to be furnished by the exhibitor. All animals must be properly bedded and watered at all times. No carpeting allowed.
- 13. Exhibitors are responsible for showing at the head of their own animals in all classes. Exhibitors may have help with a second animal in a class by others, including non-exhibitors, provided the help is 21 years old or under as of January 1st. All show help must abide by NEYSS rules including Rule 15. Co-chairmen may ask any showman for age verification.
- 14. Showing sheep on a halter is optional. (Breed secretaries encourage inexperienced and younger showmen to use halters). All animals must be washed, except for wool breeds, which must be properly prepared for show.
- 15. All exhibitors must be clean and neat. Accepted exhibitor attire will be an appropriate shirt and long solid-colored pants in good repair. No sweats, revealing attire, shirts with graphics or logos (including farm logos) will be allowed. 4H and FFA logos are accepted. Proper foot attire must be worn at all times.
  - **NOTE:** Sunday attire will include the 2020 NEYSS issued t-shirts. NEYSS t-shirts shall be worn by all exhibitors for the entire show day.

- 16. A breed must meet the minimum requirements to show as an individual breed of three (3) exhibitors and ten (10) breeding sheep. If any breed does not meet requirements, they will be shown in AOB meat or wool.
- 17. Youth participants are solely responsible for sheep handling and show preparations. Limited adult help to exhibitors for show preparation will be allowed with permission from guardian, breed secretary, and Show Chairmen. This show rule officially starts on Friday at 10:00 am and continues through the end of the show on Sunday. If an exhibitor feels he/she needs instructional help, they should see their breed secretary first.

# **Massachusetts Animal Health Regulations**



Special Note: Massachusetts COVID-19 response orders supersede all other exhibition guidance. Please visit mass.gov/covid-10updates for the most current information and updates.

In addition to complying with all laws and regulations governing animal health issues all fairs must adopt and enforce the following rules for governance of the fair:

#### 2020 Fairs - Animal Health Rules

NO animal will be admitted to the fairgrounds unless it meets the requirements below. NO animal is to be unloaded or enter a barn or tie-out stall until the animal and its paperwork have been inspected and approved for entry.

#### General Rules for All Animals: See M.G.L. c. 128 §2C. 129 §2

- 1. All animals must be in proper physical condition, be properly identified and free of visual evidence of infectious, contagious or parasitic disease at time of arrival. Specific diseases and conditions which will disqualify an animal for entry are identified for each species in the following sections of the rules. Animals of any species with open or draining wounds will not be approved for entry.
- 2. Evidence of infectious, contagious or parasitic disease or failure to produce the necessary documents for health certification, vaccination or testing will result in the animal's rejection for entry. THE INSPECTOR'S DECISION IS FINAL.
- 3. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only, and except for surgical procedures performed by
- a duly-licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 4. Official ID: See Final Rule: Summary of Traceability for Livestock Moved Interstate (Summary of general Requirements by Species)
  All livestock must have proper official, individual ID as required for the species, e.g. official metal ear tag, tattoo, scrapie tag, or microchip. Registration forms must accompany health certificates when used as part of official identification.
  5. Health Certificates: --

One Official Certificate of Veterinary Inspection (OCVI) may be allowed for animals of the same species to be exhibited at fairs or shows in any of the New England states (CT, \*ME, MA, \*\*NH, RI, and \*\*\*VT) when submitted with an itinerary of the dates and locations of the events at which the listed animals are expected to be shown. Only animals that are healthy at the time of shipment may be moved. Note that \*ME, \*\*NH, and \*\*\*VT have additional requirements. Certificates of veterinary inspection in these states are valid for a shorter period of time and may have additional language, movement and permit requirements.

For the 2020 Show and Fair Season, livestock animals being exhibited in New England states must have official certificates of veterinary inspection (OCVIs) that meet the following requirements:

- a. MA, and RI: OCVIs issued on or after January 1, 2020 may be used for those animals being shown at multiple fairs and shows in CT, MA, and RI through the 2020 show/fair season ending October 31, 2020.
  - i. CT and ME: An importation permit for exhibition animals is also required. Contact CT Dept. of Agriculture (860-713-2504) or ME State Veterinarian's Office (207-287-3701) for permits or questions.
  - ii. MA -Note: The Big E Fairgrounds in West Springfield requires a CVI issued within the prior 30 days for all horses entering the premises for any show, fair, or exhibition.
  - iii. NH: \* NH: To qualify for the extended CVI, animals exhibited in NH must originate in a New England state and move on OCVIs issued on or after April 1, 2020 to participating NH fairs and shows from July 1 to October 31. The extended CVI is not available for animals that do not reside in New England. Contact NH State Veterinarian's Office (603) 271-2404 for details and permits.
  - iv. \*\*\*VT: Contact the VT Animal Health Office (802-828-2421) for specific import requirements that deviate from the general information in this letter and must be met for legal import of livestock.
- b. A single OCVI from the animals' home state may be completed for travel to and from the New England states in which the animals will be exhibited. MA animals being shown ONLY in MA may substitute a signed, dated letter on the letterhead of an accredited veterinarian for an OCVI if all required information is included and all additional requirements are met.
- c. Multiple animals of the same species may be listed on one health certificate with appropriate individual IDs and descriptions. Animals of different species may not be listed on the same official health certificate.
- d. An itinerary of the names and locations for each New England fair or show at which owner expects to show the listed animals and the dates when each animal are expected to be on each site, must be prepared by the owner and presented to the veterinarian at the time the OCVI is written.
  - i. A copy of this planned itinerary must be attached to the official health certificate (import and export) for it to be used for more than one fair or show.
  - ii. That proposed list should be signed by the veterinarian and the owner/ exhibitor and reference the relevant OCVI number(s).
- e. The name and address of the first show or fair where the listed animals will be exhibited is to be used as the "destination" on the OCVI form. In addition, "See attached list" or a similar statement directing Animal Health Officials or Fair Inspectors to the attached proposed itinerary must be included.
- f. Exhibitors must keep an accurate list of the show locations and dates when their animals were actually on the show/fairgrounds. This record must be available to fair inspectors at each inspection and check-in.
- g. Any animal listed on an OCVI that becomes sick must remain home. If the animal is refused entry to any exhibition during 2020 for health reasons it must have a new health certificate issued by an accredited veterinarian within 30 days of the next interstate movement.
- h. Any New England state may end their participation in this agreement and revert to the standard published requirements for livestock imports in the state at any time, in the event of foreign animal disease outbreak or changes to state legislation.

#### Sheep: See 9 CFR 79 and Massachusetts Emergency Order 1-AHO-06.

- 1. No sheep will be allowed entry from flocks in which Scrapie has been diagnosed or in which animals are under surveillance for Scrapie during the previous eighteen months. Based on the Federal Scrapie Eradication Program (FSEP), goats and sheep of any age or sex brought to show or exhibition from either out of state or within state must possess a USDA official individual identification tag or registry tattoo accompanied by current registration papers consistent with the requirements of the FSEP and the Massachusetts Emergency Order 1-AHO-06. Information is available from USDA-APHIS at 508-363-2290.
- 2. No sheep will be permitted entry from flocks in which soremouth has existed or in which sore mouth Vaccine has been administered in the previous sixty (60) days.
- 3. Sheep must be free from visual evidence of foot rot, sore mouth, pink eye, ringworm, and open and draining wounds. While not required, it is strongly recommended that sheep be currently vaccinated against rabies.
